- The EMHSCA Implementation committee is responsible for the EMHSCA event tasks. A series of 3 webinars were provided in the 2nd half of 2021.
- A new event was delivered on 12th August 2021. 'Professionals Navigating the East with Carers' aimed to improve staff knowledge of carer needs and available supports. This online forum was delivered to 92 staff representing 33 health and community services across Eastern and North Eastern Melbourne.
- The Annual EMHSCA 'MH and Cooccurring Issues Epxlored Workshop' was delivered as a 2 part online workshop series on the 11th and 18th November. There were 59 attendees from 23 health and community services.
- The large service navigation forum originally planned for 2020, has been postponed to 26.05.2022 at the Box Hill Town Hall.
